SUBJECT: MINUTES OF THE LEAVENWORTH COMMUNITY SERVICE ORGANIZATION (CSO) QUARTERLY MEETING HELD THURSDAY 11 April 2013

1. The Leavenworth Community Service Organization conducted its quarterly meeting on Thursday, April 11, 2013 at the Richard Allen Cultural Center & Museum, 412 Kiowa Street, Leavenworth, Kansas. Advance notice of the meeting sent to members proposed the following discussion topics:

- Other concerns for the good of the order

2. Organizational representatives were asked to sign-in and check the information on the contact roster. Leavenworth CSO officers and organizations present and represented are *italicized and fonted in red* on CSO Roster on <u>attachment 1.</u>

4. The meeting was called to order at 6:30 pm by CSO President Ron Coaxum with welcome remarks and an opening prayer. Each attendee introduced him/herself and their organization. The roster was reviewed; CSO reps not in attendance were acknowledged during the roster review.

5. Michael Law (Alpha Phi Alpha) moved to adopt the agenda as printed. The motion was seconded by Rachel Inabinett (CSO Treasurer) and approved unanimously. Laura Coaxum (CSO Secretary) moved to accept the minutes contingent on correcting Ann Moss email address. The motion was seconded by Rik E. Jackson (CSO Vice President) and approved unanimously.

6. CSO Secretary Laura Coaxum presented a brief historical review of CSO activities.

7. CSO Treasurer Rachel Inabinett presented a CSO financial report. The current balance in the CSO account is \$5,381.40. The balance from the last quarterly report has increased by 3,015.85 due to income from to the Black History Month Program.

8. Representatives from affiliated organizations shared their organizations' schedules of events through September 2013.

• Ann Moss (Delta Sigma Theta) announced the Leavenworth Alumnae Chapter's annual signature event on April 20th at KCI Airport Marriott. This year's theme is "Harlem Nights" and tickets are \$50.

• Louise Turner announced the Socialite Club annual Gospel Fest on April 27th at Independent Baptist Church, 4 p.m., free of charge.

• Azora Smith (Art In Motion) solicited support for AIM's upcoming event featuring "Stogie Kenyatta in a Broadway-style 'One-Man Show' of 'The World is My Home' about the Life & Times of Paul Robeson". The show takes place in Leavenworth on Saturday and Sunday, June 1-2, 2013.

• Sandi Smith (Richard Allen Cultural Center and Museum - RACCM) announced Bethel AME Church's annual Vacation Bible School for all ages from 3-7 June.

• Ann Moss (Delta Sigma Theta) and Johnnie Wade (Prince Hall Masons) announced their organizations' participation in Leavenworth's Relay for Life in support of the American Cancer Society on 7-8 June at the Warren Middle School's Track.

• Phyllis Bass (RACCM) announced the RACCM's annual Summer Program for youth from 10-21 June at the Center.

Louise Turner announced the Socialite Club will celebrate its 50th Anniversary on September 7, 2013.

9. The 6th Annual Jazz by the River Fundraising Concert benefitting the Richard Allen Cultural Center (RACCM) will take place on Saturday, August 17, 2013. RACCM is again inviting all CSO units to partner with them by serving on committees, volunteering services, taking sponsorship, making donations and selling tickets as an organization for a 25% rebate on total ticket sales of ten (10) or more tickets. All CSO reps were asked to take this issue back to their organizations for a decision by June 1st. Once, decision is made, each organization is to contact CSO Secretary Laura Coaxum with the organization's decision. The deadline for reporting this is <u>June 1, 2013</u>.

10. The "Year-end" cookout was discussed. Traditionally, the first Sunday in June is the date the event is held. However, AIM's June 1-2 event conflicts with Sunday, June 2nd. Sunday, May 26 (day before Memorial Day) and Sunday, June 9, 2013 were discussed as alternate dates. Andre' Randolph (Omega Psi Phi) moved to hold the event on Sun, June 9, 2013. Mike Law (Alpha Phi Alpha) seconded the motion. The vote was unanimous to approve Sunday, June 9, 2013 as the date. Andre' Randolph (Omega Psi Phi) will ask his organization to provide a Committee Chair for the year-end cookout. Other organization representatives volunteered to head sub-committees as shown on <u>attachment 2</u>.

11. CSO President Ron Coaxum asked CSO representatives to support a fund drive by the VFW to replace the American Flags displayed at the Leavenworth National Cemetery. Deadline for donations is **April 30, 2013.** (See details on **attachment 3**)

12. Felix Sanchez of the VFW Post 12003 invited all organizations to attend a free band concert on 24 May 2013 at the Leavenworth High School. 
